JOB DESCRIPTION

Work involves training for and participating in duties of protecting life and property through the performance of firefighting and emergency service activities. volunteer firefighters are required to learn and participate in the operation of fire apparatus and the performance of hazardous tasks under emergency conditions which may require strenuous exertion under such conditions as fire, smoke, heat, and cramped surroundings.

Essential Functions:

- Complete training for Essentials of Firefighting and Firefighter I certification. This training and certification involve laying and connecting hose, operating fire nozzles, climbing ladders, using power tools, and other various firefighting duties
- Wearing a self-contained breathing apparatus (SCBA) and operating in low to no visibility environments.
- Respond to alarms and extinguish fires
- Respond to and render assistance in emergency situations
- Clean and inspect equipment and apparatus and notify chain-of-command of deficiencies
- Keep fire station, equipment, and grounds in a clean and orderly condition
- Participate in weekly training (drill) and instruction sessions
- Acquire and retain a thorough knowledge of the borough to include street, buildings, water supply (hydrants), unusual hazards, and related items
- Perform various public relations details and/or community education talks
- Perform all work duties and activities in accordance with Fire Company policies, procedures, and by-laws

Other Duties and Responsibilities:

- May respond to emergency calls for specialized services such as hazardous materials, confined space rescue, vehicle extrication, and technical rescues which may include high angle rope, below grade, swift water, trench and collapse rescues
- May respond to non-emergency calls providing a wide range of public service activities
- May be assigned other duties by Fire Company officers

Minimum Qualifications:

- Be at least 16 years of age for junior membership or 18 years of age for regular, active membership
